**“CALLING ALL COMMUNITY-BASED PEOPLE’S ORGANIZATIONS OR NON GOVERNMENTAL ORGANIZATIONS (NGOs) OR PRIVATE ORGANIZATIONS, INCLUDING BUSINESS AND PROFESSIONAL GROUPS AND OTHER SIMILAR AGGRUPATIONS TO APPLY FOR ACCREDITATION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD OF CANLAON CITY “**

WHEREAS, Article 62 of IRR of RA 7160, otherwise known as the Local Government Code of 1991, all LGUs are mandated to promote the establishment and operation of people’s organizations, NGOs and the private sector to make them active partners in the pursuit of local autonomy and shall be directly involved in plans, programs, projects and activities of LGUs;

WHEREAS, Article 64 (a) thereof mandates that, within thirty (30) days from the organization of the newly elected sanggunian, each sanggunian shall call all community based peoples’ organization or NGOs, including business and professional groups and other similar aggrupations to apply for accreditation in the local sanggunian;

WHEREAS, hereunder are the needed supporting documents of the Application for Accreditation wit:

- 1) Duly Approved Board Resolution applying for accreditation;

- 2) Certificate of Registration with either Securities and Exchange Commission (SEC), Cooperatives Development Authority (CDA), Department of Labor and Employment (DOLE), Department of Social Welfare and Development or, any recognized Non Government Agencies (NGAS) that accredits people's organizations, NGOs or the private sector;
- 3) Organizational Purpose and Objectives that includes the List of Officers and Members;
- 4) Community Based and Track Record of at least One (1)-Year;
- 5) Reliability as evidenced by the preparation of annual reports and conduct of annual meetings duly certified by the Board Secretary of the organization;
- 6) Accomplishments and
- 7) Financial Data

WHEREAS, it being within the ambit of law ;

NOW, THEREFORE:

On Motion of City Councilor Clementino B, Llanes and duly seconded by City Councilor Diego A. Santiago II, the body,

RESOLVES, to adopt this resolution- CALLING ALL COMMUNITY-BASED PEOPLE'S ORGANIZATIONS OR NON GOVERNMENTAL ORGANIZATIONS (NGOs) OR PRIVATE ORGANIZATIONS, INCLUDING BUSINESS AND PROFESSIONAL GROUPS AND OTHER SIMILAR AGGRUPATIONS TO APPLY FOR ACCREDITATION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD OF CANLAON CITY
