INVITATION TO BID FOR THE *CONSTRUCTION OF BOX CULVERT*

The Local Government Unit of Canlaon City, through the AIP 2026 intends to apply the sum One Million, Eight Hundred Seventy-two Thousand, Two Hundred Eighty-five & 06/100 (P1,872,285.06) being the Approved Budget for the Contract (ABC) to payments under the contract for the *CONSTRUCTION OF BOX CULVERT, Upper Bon-bon, Brgy. Binalbagan, Canlaon City*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of Canlaon City, now invites bids for *CONSTRUCTION OF BOX CULVERT, Upper Bon-bon, Brgy. Binalbagan, Canlaon City*.¹ Completion of the Works is required 120 Calendar Days. Bidders should have completed, within ten (10) years prior from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.** (ITB).

Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from *Local Government Unit, Canlaon City at the Office of the Bids and Awards Committee, Canlaon City* and inspect the Bidding Documents from 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders on Starting May 15, 2026 to June 9, 2026 until 10:00 AM at the Office of the Bids and Awards Committee, Canlaon City, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand (P5,000.00) Pesos. The Procuring Entity shall allow bidder to present its proof of payment for the fees by facsimile.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

¹ A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

The Local Government Unit of Canlaon City will hold a Pre-Bid Conference on May 26, 2026-11:00 AM at the Office of the Bids and Awards Committee, Underpass, City Hall Ground, Canlon City, which shall be open to prospective bidders.

Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through on or before June 9, 2026-10:00 AM at the Office of the Bids and Awards Committee, Underpass, City Hall Grounds, Canlaon City.

All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

Bid opening shall be on June 9, 2026-10:00 AM at Office of the Bids and Awards Committee, Underpass, City Hall Grounds, Canlaon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

Bids will be opened in the Presence of the bidders' representative who choose to attend at the address below, late bids shall not be accepted.

For the purpose of constituting a quorum, either the physical and virtual presence of the BAC member shall be considered pursuant to GPPB Resolution No. 09-2020.

The Local Government Unit of Canlaon City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
