**INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF VARIOUS

The Local Government of Canlaon City, through the AIP 2026 intends to apply the sum Two Hundred Thirteen Thousand, One Hundred Thirty-six & 38/100 (P213,136.38) being the ABC to payment under the contract for the **Supply and Delivery of Various Construction Materials for the Construction of Pathway, Sitio Upper Amancio Fabillar Area, Brgy. Pula, Canlaon City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Local Government Unit of Canlaon City* now invites bids for **Supply and Delivery of Various Construction Materials for the Construction of Pathway, Sitio Upper Amancio Fabillar Area, Brgy. Pula, Canlaon City**. Delivery of the Goods is required *7 calendar days after issuance and receipt of Notice to Proceed*. Bidders should have completed, at least *Ten (10) years* from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009. Bidding is open to all interested Bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR.

Interested Bidders may obtain information from the City Government of Canlaon City thru the Office of the Bids and Awards Committee and inspect the Bidding Documents during office hours (8:00 AM to 5:00PM), Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on **May 16, 2026 to June 9, 2026 until 10: 00 AM at the Office of the Bids and Awards Committee, Canlaon City**, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amount of Five Hundred Pesos (P500.00). The Procuring Entity shall allow the bidder to present proof of payment for the fees through facsimile.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission on or before **June 9, 2026-10:00 AM at the Office of the Bids and Awards Committee, Underpass, City Hall Ground, Canlaon City**. Late bids shall not be accepted.

All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

Bid opening shall be on **June 9, 2026-10:00 AM at the Office of the Bids and Awards Committee, Underpass, City Hall Ground, Canlaon City**, and/or via <https://canlaoncity.gov.ph>. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

For the purpose of constituting a quorum, either the physical and virtual presence of the BAC member shall be considered pursuant to GPPB Resolution No. 09-2020.

The *Local Government Unit of Canlaon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70<sup>1</sup> of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
